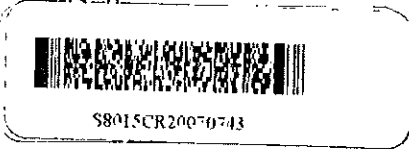

STIPULATION OFFERED
BY THE STATE

13 COMES NOW, the State of Arizona, by the Mohave County Attorney, and hereby
14 agrees to stipulate to not using any evidence seized from the State of Texas including
15 any materials seized specifically by Texas law enforcement during the April, 2008,
16 search of the "YFZ Ranch". The State agrees at this time in order to avoid an
17 Evidentiary Hearing in this case in February, that it will not use any evidence seized by
18 the Texas authorities from the YFZ Ranch in its' case-in-chief, during cross-examination
19 of any called defense witnesses or as rebuttal evidence. In summary, the State will
20 agree not to use this evidence for any purpose whatsoever in either of the two cases
21 pending against the Defendant, Warren Jeffs. The State believes that this should take
22 care of the pending Evidentiary Hearing and there should be no need to proceed with
23 said hearing at any time.
