**IT IS ORDERED** setting this matter for an **Omnibus Hearing on Monday, May 19, 2008 at 8:00 a.m.**

Discussion ensues regarding potential motions to be filed by the Defense.

The Defense filed a Motion to designate this case as a complex case.

The Court has not received this Motion yet.

The State has no objections

The Court will not rule on the Motion until the Court actually sees it, but anticipates it will be granted.

The Court advises counsel that all original motions should be filed with the Clerk's office, but a courtesy copy faxed directly to the Court.

Mr. Piccarreta makes statements about remarks made by an investigator at a recent local gathering which may have been inappropriate. Discussion ensues.

The Court addresses Counsel about a possible Motion for Change of Venue.
