1 I, Alexis Danneman, declare as follows:

2 1. I am over 18 years old, and I have personal knowledge of the matters contained in
3 this declaration.

4 2. I am a partner at Perkins Coie LLP and counsel of record for Defendant Kris Mayes
5 in the above-captioned matter.

6 3. I submit this declaration in support of Ms. Mayes' joinder in the motion to
7 compensate ballot inspectors and further motion for an award of costs under A.R.S. § 12-341.

8 4. With respect to the ballot inspection, my colleague, Rahgan Jensen, attended the
9 Maricopa County inspection on behalf of Ms. Mayes. Ms. Jensen's hourly rate is \$445/hour. The
10 ballot inspection lasted about 6.5 hours. Thus, the value of Ms. Jensen's time equals \$2,892.50.
