1 Pending before this Court are the following motions, along with certain responses and
2 replies:

- 3 1. Contestants' Motion for an Order Reflecting Additional Rulings of the Court, filed
4 December 28, 2022.
- 5 2. Defendant Kris Mayes' Motion for Attorneys' Fees, filed January 3, 2023 and
6 supplemented January 17, 2023.
- 7 3. Arizona Secretary of State's joinder in Defendant/Contestee Kris Mayes's Motion for
8 Attorneys' Fees, filed January 4, 2023.
- 9 4. Navajo County's Motion to Compensate Ballot Inspectors, filed January 4, 2023.
- 10 5. Mohave County Defendants' Joinder in Navajo County Defendants' Motion to
11 Compensate Ballot Inspectors, filed January 9, 2023 and April 17, 2023.
- 12 6. Defendant Kris Mayes's Joinder in Motion to Compensate Ballot Inspectors, filed
13 January 11, 2023.

14 While these motions have been pending, Contestants have filed a notice of appeal
15 triggering action in the Arizona Court of Appeals. Defendants Kris Mayes and the Secretary of
16 State have moved to dismiss the appeal. [See Motion to Dismiss, attached as Ex. 1]

17 And, yesterday, Contestants separately filed a special action at the Arizona Supreme
18 Court that, among other things, argues that this Court has "abused its discretion" by failing to
19 issue final judgment. [See Petition for Special Action, attached as Ex. 2, at 18]

20 Contestants' failure to request final judgment language, coupled with their various
21 filings, have created unnecessary procedural complexity and expense.

22 Defendant Kris Mayes hereby respectfully requests that this Court resolve the pending
23 motions and enter judgment "immediately," as the statute requires. A.R.S. § 16-676(B).
