1 The parties hereby request this Court to enter a final judgment pursuant to Arizona 2 Rule of Civil Procedure 54(c).¹ 3 This Court entered a signed order on August 31, 2023. That order contained finality language required by Arizona Rule of Civil Procedure 54(c). But that order also left open, 4 5 and requested additional orders, related to the ballot inspection costs associated with ballot 6 inspections in Mohave and Navajo Counties. Thus, the Court's order was not actually final 7 and appealable pursuant to Arizona Rule of Civil Procedure 54(c). 8 Therefore, to aid the Court with the two remaining issues and facilitate entry of a 9 final appealable judgment, the parties have conferred and submit for this Court's 10 consideration a form of judgment: Indicating that Defendant Kris Mayes has withdrawn her request for costs 11 (but not her request to be compensated for ballot inspection), and thus, amending this 12 13 Court's prior order so that it does not reflect an award of her costs; 14 2. Awarding Defendant Mohave County ballot inspection costs of \$1,800.00; 3. Awarding Defendant Navajo County ballot inspection costs of \$542.00; and 15 4.
