ORDER DISMISSING APPEAL

The court has considered the motion to dismiss and the response. The court has also considered the notice of supplemental authority.

In an unsigned minute entry filed December 28, 2022, the superior court found in favor of appellees and denied appellant's petition. Appellees subsequently filed a motion for attorneys' fees. Appellant filed a motion for new trial. In unsigned rulings filed July 14, 2023, and July 17, 2023, the court denied the motion for new trial. Appellant filed a notice of appeal on July 18, 2023.

The notice of appeal is premature and a nullity because it was filed while the motion for attorney fees was pending and before a final judgment was entered. *Camasura v. Camasura*, 238 Ariz. 179, 182-83, ¶¶ 9-16 (App. 2015); *Fields v. Oates*, 230 Ariz. 411, 414-15, ¶¶ 10-14 (App. 2012). Therefore,

IT IS ORDERED dismissing this appeal. Nothing precludes appellant from filing a timely notice of appeal after a final judgment is entered.
