1 In its December 20, 2022 Minute Entry, this Court found that “a limited inspection of
2 ballots is appropriate under A.R.S. § 16-677.” [Dec. 20, 2022 Minute Entry at 4] That statute
3 requires any ballot inspection to be performed before “three persons”—“one selected by each of
4 the parties and one by the court.” A.R.S. § 16-677(B). Under A.R.S. § 16-677(B), Contestee Kris
5 Mayes notifies the Court that she nominates **Rahgan Jensen** as her designated ballot inspector.

6 Kris Mayes further requests that the Court appoint Ms. Jensen pursuant to A.R.S § 16-
7 677(B). Kris Mayes also respectfully requests this Court appoint its representative as the third
8 inspector as further required by A.R.S § 16-677(B).
