1 Plaintiffs named Maricopa County Co-Director of Elections REY VALENZUELA,  
2 Pima County Director of Elections CONSTANCE HARGROVE, and Yuma County Voter  
3 Services Coordinator SARAH HOWARD as defendants in this lawsuit. All three were sued  
4 in their official capacities, and all three are represented by the undersigned Maricopa County  
5 Deputy County Attorneys.

6 Maricopa County Recorder STEPHEN RICHER, Pima County Recorder  
7 GABRIELLA CAZARES-KELLY, and Yuma County Recorder ROBYN STALLWORTH

20 in this action in place of Constance Hargrove.

21 • Yuma County Recorder Robyn Stallworth Pouquette is substituted as a  
22 defendant in this action in place of Sarah Howard.
