**A. FORECLOSING THE RIGHT TO
REDEEM A TAX LIEN**

AFTER HEARING, THE COURT FINDS (Either A or B):

_____ **A. Default was properly entered:** Defendant(s) were served with the Complaint in compliance with the Arizona Rules of Civil Procedure and failed to appear and answer Plaintiff's Complaint.

To pay for delinquent taxes legally levied and assessed against the property and interest, penalties and charges, the Mohave County Treasurer sold Plaintiff the tax lien on the property, located in Mohave County, as follows:

_____ **A. Defendant(s) right to redeem is foreclosed:** The sale of the tax lien on the property, Certificate of Purchase, and service of process is valid. The property has not been redeemed. Defendant(s) right to redeem the property is forever foreclosed and Defendant(s) are barred forever and stopped from having or claiming any right or title adverse to Plaintiff.

The Mohave County Treasurer shall execute and deliver to Plaintiff a deed conveying the property upon presentation by the Plaintiff of a certified copy of this judgment.

_____ **B. Defendant(s) shall pay Plaintiff's costs and attorney fees:** Defendant(s) redeemed the property from sale. Defendant(s) shall pay Plaintiff \$_____ for costs and attorney fees, plus interest on that amount at the following rate of interest per annum from the date paid by Plaintiff until paid in full: _____ %.
