**ORDER TO RESTRICT PUBLIC ACCESS  
TO ADDRESS AND TELEPHONE NUMBERS  
IN SPECIFIED PUBLIC RECORDS**

The Court, having reviewed the attached affidavit(s), finds that the requirements of A.R.S. Section 11-483, 11-484, 16-153, and 28-454 have been satisfied and the affiants listed within this order and on the attached affidavits are entitled to have the records maintained by the entities indicated below, containing affiant's name, residential address and telephone number, closed to public inspection.

- ☐ **MOHAVE COUNTY RECORDER:** IT IS ORDERED sealing for five years the affiant's residential address and phone number appearing in instrument and writings recorded by the County Recorder and the unique identifiers and recording dates contained in indexes of recorded instruments maintained by the County Recorder. The Mohave County Recorder shall seal the copy of the order pertaining to the affiant and shall accomplish the foregoing no later than 10 days from receipt of this minute entry order.
- ☐ **MOHAVE COUNTY ASSESSOR:** IT IS ORDERED sealing for five years the affiant's residential address and phone number appearing in instruments, writings and information maintained by the County Assessor. The Mohave County Assessor shall seal the copy of the order pertaining to the affiant and shall accomplish the foregoing no later than 10 days from the receipt of this minute entry order.
- ☐ **MOHAVE COUNTY TREASURER:** IT IS ORDERED sealing for five years the affiant's residential address and phone number appearing in instruments, writings and information maintained by the County Treasurer. The Mohave County Treasurer shall seal the copy of the order pertaining to the affiant and shall accomplish the foregoing no later than 10 days from the receipt of this minute entry order.
- ☐ **VOTER REGISTRATION:** IT IS ORDERED sealing for five years the affiant's residential address and phone number and voting precinct number and those of any individuals identified in the accompanying affidavit that appear in voter registration records. The names of each person included on the affidavit shall be listed by the Mohave County Recorder as registered voters in their appropriate voting precincts and shall be entitled to vote in all elections permitted by law. A copy of this order and the original voter registration forms shall be delivered to the County Recorder of Mohave County. The Mohave County Recorder shall accomplish the foregoing no later than 120 days from the receipt of the minute entry order.
- ☐ **MOTOR VEHICLE DIVISION:** IT IS ORDERED sealing the affiant's residential address and phone number and those of any individuals identified in the accompanying affidavit that appear that appear in Motor Vehicle Division records for an indeterminable amount of time. The Department of Transportation, Motor Vehicle Division shall accomplish the foregoing no later than 150 days from the receipt of the minute entry order.

**IT IS FURTHER ORDERED** that the Clerk of the Superior Court shall file and seal the original affidavit and distribute a copy of this order to the appropriate agency(s) as indicated in the forgoing section of this order.

**IT IS FURTHER ORDERED** that the information in this order and in the attached affidavit is not a public record and this information shall not be disclosed by the Clerk of the Superior Court, the Mohave County Recorder, Mohave County Assessor, Mohave County Treasurer or by the Department of Transportation, Motor Vehicle Division.
