The Mohave County Board of Supervisors has approved and adopted Resolution no. 2003-01 and Ordinance no. 2003-01, granting authority to adopt a schedule of additional fees for supplementing the funding available for improvement of the court's automation systems and other services provided by the court, and to improve the operation of the court and processing of cases. The resolution and ordinance provide for a \$60 fee to be added to filing fees or appearance fees in any superior court cases which currently require such fees, and a \$50 fee to be assessed against persons who fail to appear for hearings and cause issuance of bench warrants or arrest warrants and the additional services required of court staff as a result.

There are miscellaneous fees charged by the Clerk of Superior Court, and set by statute or Court Rule, which are not affected by this resolution. The Clerk has a Filing Fee Schedule which lists all fees charged and collected by the Clerk of Superior Court. The schedule is attached hereto and represents the comprehensive fee schedule as of the effective date of this order, and is incorporated herein by this reference.

IT IS ORDERED that effective February 18, 2003, a Superior Court Improvement Fund fee of \$60 shall be assessed and collected by the Clerk of Superior Court, in accordance with the new Filing Fee Schedule attached hereto, unless the fees are waived or deferred by order of a judge or special commissioner authorized to enter such order.

FURTHER ORDERED that in any superior court case in which a party fails to appear for a hearing, and a bench warrant or arrest warrant is issued, that a Warrant Fee of \$50 shall be assessed, and shall be paid by the party who failed to appear in addition to any secured appearance bond or cash bond and prior to release from custody, unless the court defers payment of the fee.

FURTHER ORDERED that all fees collected pursuant to this order shall be tendered to the Mohave County Treasurer for deposit as required by Ordinance 2003-01.
