THIS COURT HEREBY accepts and adopts the Hearing Officer's report in its entirety with the following exceptions made under the authority of Judicial Merit System Rule 603:

- 1. Paragraphs 3 and 4 of the Conclusions of Law and the entire Recommendations section are overruled and not adopted for the reasons set out in Respondent's Motion for Reconsideration, pp. 2-3.
- 2. The first sentence of paragraph 13 of the Hearing Officer's report is overruled and not adopted for the reasons set out in Respondent's Motion for Reconsideration, p. 4.
