Further changes to the Court's current case assignment schedule are necessary to meet the demands of increased case filings and to ensure effective judicial workflow. To that end the following changes are being adopted to the case assignment schedule:

- Judge Conn's criminal assignment will increase to 40% and Judge Carlisle's criminal assignment will be reduced to 30% (see attached matrix)
- The Kingman civil cases (cases ending in #6) assigned to Judge Roth will now be assigned to Judge Gurtler
- Judge Roth's domestic relations case assignment will be reduced by 10% with Judge Williams and Judge Jantzen each receiving 5% of these cases (see attached matrix)
- All Orders of Protections filed in Kingman will now be handled by an assigned Duty Judge on a rotating weekly schedule (see attached schedule)

IT IS ORDERED adopting the above listed case assignment modifications for the Superior Court Judicial Officers in Mohave County effective Monday, October 15, 2012.

IT IS FURTHER ORDERED that aside from the changes noted above all other case assignments remain the same as outlined in Administrative Orders 2012-32 and 2012-15.
