
As a result of the creation of a new Judicial Division and the subsequent appointment of the Honorable Rick Lambert to fill that position, it is necessary to change the current case assignments in order to ensure the effective administration of justice within the court. The judges have reviewed and agreed to the case assignment schedule outlined in the accompanying documents. Therefore,

IT IS ORDERED adopting the procedures and schedules outlined in the accompanying documents as the procedure for assignment of cases to the judicial officers in Mohave County Superior Court. The effective date of the changes will be April 1, 2013, with the exception of juvenile dependency matters in Lake Havasu City which will change as of June 3, 2013.

IT IS FURTHER ORDERED that contested orders of protection will be heard by the judge assigned to the underlying case, if any. It is only the initial filing that is covered by the case assignments. Additionally when the assigned Judge for an order of protection is not available the matter will be referred to another Judge according to the following schedule:

- Bullhead City: Judge Williams
- Kingman: Judge Roth
- Lake Havasu City: Judge Bartlett
