
The Mohave County Board of Supervisors has approved and adopted Resolution No. 2016-10 and Ordinance No. 2016-01, granting the authority to impose additional fees to supplement available funding needed to continue court operations.

The resolution provides for an additional \$40 to be added to the existing fee for filing an initial complaint/petition and answer/response in all case types. There are miscellaneous fees charged by the Clerk of Superior Court, which are set by statute or court rule, that are not affected by this resolution. The Clerk has a complete Filing Fee Schedule which lists all fees charged and collected by the Superior Court. The Schedule is attached hereto and represents only the changed fees as of the effective date of this order, and is incorporated herein by this reference.

**IT IS ORDERED** that effective April 1, 2016, a Local Court Improvement Fee of \$100 shall be assessed and collected by the Clerk of the Superior Court, in accordance with the new Filing Fee Schedule attached hereto, unless the fees are waived or deferred by order of a judge or special commissioner authorized to enter such order.

**FURTHER ORDERED** that additional fees collected pursuant to this order shall be tendered to the Mohave County Treasurer for deposit in existing funds called the Court Improvement Automation Fund, the Court Improvement Electronic Document Management System Fund and the Court Improvement Other Fund
