
**WHEREAS**, there is a need to appoint qualified persons to serve during absences by judges in Mohave County Superior Court. Justices of the Peace Jill Davis and John S. Taylor are full-time justices of the peace, otherwise qualified to serve as superior court judges pro tempore, and willing to assist the superior court by hearing cases on an occasional basis as assigned. In addition, during the annual judicial conference, and possibly during local continuing education programs, there may be occasions on which no superior court judges are available for emergency matters.

John S. Taylor	Arizona State Bar #010732


**IT IS FURTHER ORDERED** that Jill Davis and John S. Taylor shall serve without compensation above their established salaries as justices of the peace.
